## Resolution 16-84: RESOLUTION IN SUPPORT OF REALIGNING THE WARREN COUNTY AGRICULTURE DEVELOPMENT AREA (ADA) IN INDEPENDENCE TOWNSHIP

WHEREAS, on September 13, 2016 the Independence Township Committee supported by resolution the realignment of the Warren County Agriculture Development Area (ADA) within Independence Township to include approximately 66.25 acres of contiguous farmland assessed property to the County ADA with Greco, Block 16 Lot 1, Block 17 Lot 56, Block 17 Lot 56.01, and Block 17 Lot 56.06.

**WHEREAS,** in order to keep the ADA contiguous, the following additional properties, which are not targeted farms, are to be included in the amended ADA:

- Klobocista, Ekrem %Tim Klobocista Block 17, Lot 28 (approximately 153 acres)
- Choe, Sun Chu Block 17, Lot 33 (approximately 18.25 acres)
- Piteo, Laurel LD Block 17, Lot 52 (approximately 52 acres)

In order to enhance the agriculture industry in Independence Township and promote the viability same through farmland preservation, the Independence Township Committee supports the realignment of the Warren County Agriculture Development Area (ADA) within Independence Township. This proposed change will add approximately 223.25 additional acres to the previously approved 66.25 acre amendment to the County ADA.

The impetus for modification for approved September 15, 2016 resolution is landowner interest in preserving the properties (Block 16 Lot 1 and Block 17 Lot 56, Block 17 Lot 56.01, Block 17 Lot 56.06 in Independence Township). The additional properties, Block 17 Lot 28, Block 17 Lot 33 and Block 17 Lot 52 do not meet the eligibility criteria for farmland preservation, but are merely being included in order to keep the ADA contiguous.

**THEREFORE, BE IT RESOLVED** that Independence Township hereby adopts this resolution in support of adding the above referenced properties to the Warren County ADA.

## Resolution 16-85: RESOLUTION REQUESTING PERMISSION TO CREATE A DEDICATION BY RIDER FOR STORM RECOVERY COSTS PER NJSA 40A: 4-62.1

# Resolution 16-90: INTERLOCAL SERVICES AGREEMENT FOR FIRE PREVENTION SERVICES BETWEEN THE TOWNSHIP OF WASHINGTON, MORRIS COUNTY AND THE TOWNSHIP OF INDEPENDENCE, WARREN COUNTY

WHEREAS, Independence desires to contract with Washington for the furnishing of fire prevention services as required by the Uniform Fire Code, N.J.A.C. 5:70-1.1et seq., and as hereafter set forth.

**NOW, THEREFORE, IN CONSIDERATION OF** the mutual promises, covenants and representations herein contained, the parties hereto, for themselves, their heirs, successors and assigns, hereby agree as follows:

#### I. SCOPE OF SERVICES

- Washington shall provide the services of a licensed, qualified Fire Official and/or Fire Inspector for fire prevention services to Independence, under the terms and conditions as hereinafter set forth.
- 2. The Washington Township Fire Prevention Office shall be responsible for inspections for Independence required pursuant to the Uniform Fire Code as set forth in this Agreement.
- 3. The Fire Official and Fire Inspector shall remain the sole employees of Washington and Washington shall be responsible for the administration and payment of his salary and benefits and for the supervision of the Fire Official and Fire Inspector. The parties agree that Washington will resolve any citizen inquiries or complaints regarding the services provided to Washington and Independence will resolve any citizen inquiries or complaints regarding services provided to Independence.
- 4. The Washington Township Fire Prevention Office shall provide all the hours required to provide the following services to Independence: smoke detector/carbon monoxide detector inspections and life hazard use inspections as required by the Uniform Fire Code. Non-life hazard use inspections are specifically excluded.
- 5. Independence will provide all necessary forms for use by the Fire Official and Fire Inspector at the Independence Municipal Building. All records produced by the Washington Township Fire Prevention Office regarding the fire prevention services of Independence shall be retained in the Independence Municipal Building.

#### **II. TERM OF AGREEMENT**

6. Washington shall provide the services of the Washington Township Fire Prevention Office to Independence during the term of this Agreement which shall commence on January 1, 2017 and terminate on December 31, 2017. Either party may terminate this Agreement prior to the expiration of the term upon 90 days' advance written notice to the other party, but advance written notice is not required to terminate the Agreement if the employees of the Washington Township Fire Prevention Office retire, becomes disabled or otherwise are rendered incapable of performing the duties required pursuant to this Agreement.

#### **III. PAYMENT FOR SERVICES**

7. Independence shall pay Washington the sum of \$33.29/hour for the time spent on inspections and on official fire prevention business for Independence by the

Fire Prevention Official. Said sum shall be paid to Washington upon the receipt by Independence of vouchers from Washington. Any and all inspection fees as required by ordinance or state law will be remitted to Independence.

#### IV. AMENDMENT

8. Any amendments to this Agreement must be in writing, must specify the effective date of the amendment and must be executed by the Mayor of each municipality, or his/her designated representative.

#### V. INDEMNIFICATION AND DEFENSE OF PERSONNEL

9. A. Independence shall not be liable for any negligent, reckless or intentional acts or omissions of Washington or the employees of the Washington Fire Prevention Office and Washington shall indemnify, defend and hold Independence harmless from all losses, injuries or damages caused by the negligent, reckless or intentional acts or omissions of Washington or any of its employees rendering the services et forth in this agreement. Such indemnification shall include payment of reasonable attorney's fees and costs in the defense of any claim made by a third person incident to such negligent, reckless or intentional act or omission.

B. It is recognized and understood that Washington participates in a joint insurance fund (JIF) and Independence PAIC. Washington and Independence each name each other as an additional insured on its general liability insurance policy. Washington will provide proof of automobile liability and workers compensation policies.

**IN WITNESS WHEREOF**, the parties hereto have caused these presents to be signed by their corporate officers and their proper corporate seals to be affixed hereto the day and year as indicated in the acknowledgments attached hereto and made a part hereof.

## Resolution 16-91: RESOLUTION AUTHORIZING SETTLEMENT OF MOUNT LAUREL LITIGATION

WHEREAS, the Township of Independence has filed a Declaratory Judgment Action in the Superior Court of New Jersey, Warren County, in furtherance of the Supreme Court's March 10, 2015, decision captioned In re Adoption of N.J.A.C. 5:96 & 5:97 by N.J. Council on Affordable Housing, 221 N.J. 1 (2015) (the "Supreme Court Decision"), which was assigned to the Honorable Thomas C. Miller P.J. Cv.; and

**WHEREAS**, the Township has engaged in good faith settlement discussions with interested party, Fair Share Housing Center ("FSHC"); and

**WHEREAS**, said negotiations resulted in a comprehensive Settlement Agreement between the Township and FSHC which resolves all litigation between the parties and resolves and settles all issues related to the Township' affordable housing obligations defined by COAH for the Third Round; and

**WHEREAS**, the Township recognizes that the settlement of Mount Laurel litigation is favored because it avoids delays and the expense of trial and results more quickly in the construction of homes for lower-income households; and

WHEREAS, at this time and at this particular point in the process resulting from the Supreme Court decision, when fair share obligations have yet to be definitively determined, it is appropriate for the parties to arrive at a settlement regarding a municipality's Third Round present and prospective need, instead of doing so through plenary adjudication of the present and prospective need

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Committee of the Township of Independence, County of Warren, State of New Jersey, hereby authorizes the settlement of the above referenced litigation substantially in accordance with the terms set forth in the proposed settlement documentation which is attached hereto and was reviewed by the Mayor and Township Committee.

**BE IT IS FURTHER RESOLVED** that counsel and all other appropriate Township officials and personnel are authorized to prepare any and all related documents and perform all tasks, which will effectuate the purposes of this Resolution.

#### **Resolution 16-92: Animal Control Services Agreement**

**THIS AGREEMENT**, made this January 1, 2017 between Township of Independence and Animal Control Timothy Norton, ACO and

**WHEREAS**, the Recipient has heretofore funded the expenses of its animal control officer; and

**WHEREAS**, the Provider has entered into a professional contract for the provision of Animal Control Services; and

**WHEREAS**, the Recipient and the Provider has arrived at an agreement whereby the Recipient will pay a contractual amount to the Provider, the Provider in turn assuming the aforementioned Animal Control Services.

**NOW, THEREFORE, IT IS AGREED** between the parties that this Agreement shall be entered into to memorialize the payment of the costs attributable to Animal Control Services:

#### 1) Services to be provided

- a) The Provider shall provide Animal Control Services as required by New Jersey Statute and township ordinances of the Township of Independence, as well as for boarding of animals at Happy Tails Inn. The Animal Control Officer shall be authorized to enforce (including the issuance of summonses) animal control ordinances and licensing requirements of the Township of Independence.
- b) The Provider shall provide for the investigation of wild and possible rabid animals and removal and disposal as necessary.
- c) The Recipient shall pay the contractor for those services according to the schedule set forth below.

- a) The agreement shall commence on the first of the month following the date of certification as a licensed animal control officer of the contractor retained by the Provider.
- b) The contract shall continue for two years (1/1/2017-12/31/18) following the date of commencement.
