This is a regular meeting of the Township Committee of Independence Township, Warren County, New Jersey. This meeting was called to order by Mayor Robert Giordano at 7:00 p.m. with the following announcement: "Adequate notice of this meeting was given in accordance with the Open Public Meetings Act by providing a schedule of regular meetings to the Star Gazette and The Express Times, posting a copy thereof on the Township bulletin board and filing a copy thereof in the office of the Municipal Clerk." The Pledge of Allegiance to the American Flag was led by Mayor Giordano.

## **EXECUTIVE SESSION:**

**Presentation:** Volunteers of the Independence Vienna Methodist Church Food Pantry, Sandy and George Ulmer. Chief Riley, Mayor Giordano and Township Committee thanked both of them for the tremendous support for families in need. Since 2014 when the Food Pantry was started 1103 people 696 bags were served, in 2015 2176 people 1093 bags, as of July 2016 over 1159 people, 520 bags of food. George stated the doors are always opened not just for Independence Families, George thanked all the volunteers that have helped with the Food Pantry including Chief Riley, Janet De Roma, Independence Fire Department, Great Meadows Regional School District, Centenary College, Clara Kott, Muriel Walter, and the employees of Independence Township.

**Verizon Wireless Proposal To Install A Telecommunication Facility On Township Property:** Consultant Sue Manchel presented the proposal to the Township Committee, the tower would be 150'/ 50x50 compound on Township property with fence enclosure. The lease would be for 25years, first year rent \$ 12,000 with 10% increases every 5 yrs.

## **Resolution 16-60: Resolution Authorizing Sale of Surplus Personal Property**

WHEREAS, the statute bid threshold is \$36,000; and

**WHEREAS**, the estimated fair value of the above-referenced property is less than \$5,400.00.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the Township of Independence, County of Warren, State of New Jersey that the following vehicles are hereby declared to be surplus personal property of the Township:

**BE IT FURTHER RESOLVED** that the Mayor or his designees are hereby authorized to execute any and all additional documents to effectively transfer title of the Property.

## **Resolution 16-61: Resolution Granting Soil Removal Permit to Partac Peat Corporation**

## Block 29, Lot 51 and Block 33, Lot 2.

**WHEREAS**, Section 134-3 of the Independence Township Code requires the issuance of a soil removal permit by the Township Committee where soil is removed for sale or for use other than on the premises from which the soil shall be taken; and

**WHEREAS**, the Partac Peat Corporation has made application for a soil removal permit for Block 29, Lot 51 and Block 33, Lot 2 by application dated July 8, 2016; and

**WHEREAS**, the office of the Township Engineer has issued a report in connection with said application dated August 5, 2016; and

**WHEREAS**, in the foregoing report, the Township Engineer has noted the requirement for the filing with the Township of a Restoration Bond pursuant to Section 134-6C of the Independence Township Code which is intended to ensure faithful completion of final restoration measures; and

**WHEREAS,** the facility in question has been in existence for over fifty (50) years and in the past the Township waived the Restoration Bond requirement; and

**WHEREAS,** the office of the Township Engineer takes no exceptions to the renewal of this application;

**NOW, THEREFORE, BE IT RESOLVED** on this 9th of September, 2014 that the application of Partac Peat Corporation for a soil removal permit be and the same is hereby granted effective August 2016 to August 2018; and

**BE IT FURTHER RESOLVED** that the requirement to file a Restoration Bond is hereby waived.
