### **AMERICAN RED CROSS MONTH 2019**

#### **A Proclamation**

More than 137 years ago, the American Red Cross was established as a humanitarian organization, guided by seven fundamental principles—including humanity, impartiality and independence—to provide services to those in need regardless of race, religion, gender, sexual orientation or citizenship status. Today, the American Red Cross is one of the largest humanitarian organizations in the world, and delivers its mission every day to prevent and alleviate human suffering in the face of emergencies.

Every year, the American Red Cross responds to an average of more than 62,000 disasters across the country, from small home fires to devastating massive disasters. Last year's large crises included mudslides in California, a volcano in Hawaii, wildfires in Colorado and California, destructive hurricanes in Florida and the Carolinas, and a devastating typhoon in U.S. territories. Thousands of American Red Cross volunteers provided around-the-clock shelter for disaster victims, served millions of meals and snacks with partners, and distributed millions of relief items.

In New Jersey, the Red Cross has a long history of helping our neighbors in need. **SELF-EXAMINATION OF BUDGET RESOLUTION**

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the *Township of Independence* has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2019 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the *[insert name of municipality]* that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
  - a. Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures
  - c. Cash deficit of preceding year
  - d. Reserve for uncollected taxes
  - e. Other reserves and non-disbursement items
  - f. Any inclusions of amounts required for school purposes.
2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
4. That pursuant to the Local Budget Law:
  - a. All estimates of revenue are reasonable, accurate and correctly stated,
  - b. Items of appropriation are properly set forth
  - c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.

## **RESOLUTION OF THE TOWNSHIP OF INDEPENDENCE AUTHORIZING SUBMISSION OF A HIGHLANDS INITIAL ASSESSMENT GRANT APPLICATION TO THE NEW JERSEY HIGHLANDS COUNCIL**

**WHEREAS**, in recognition of the costs associated with local government efforts to conform to the Regional Master Plan (RMP), the Highlands Act provided a funding mechanism through the creation of the Highlands Protection Fund; and

**WHEREAS**, the Highlands Protection Fund includes significant grant funds that are available for municipalities and counties seeking to conform or considering voluntary conformance with the RMP; and

**WHEREAS**, the Highlands Water Protection and Planning Council (Highlands Council) has adopted an Initial Assessment Grant Program that will fund preliminary municipal Plan Conformance activities for lands within the Preservation Area where conformance is mandatory, as well as in the Planning Area where conformance is voluntary. These grants will allow local jurisdictions to engage their professionals to assess the requirements and benefits of Plan Conformance; and

**WHEREAS**, Independence Township believes that it is in the best interest of the Township of Independence to apply to the Highlands Council for an Initial Assessment Grant to conduct a preliminary investigation, to:

1. Prepare a build out analysis of the impact of Highlands Regional Master Plan designations on lands within the Township,
2. Identify potential redevelopment areas and other lands suitable for development,
3. Identify local economic development priorities for the Township, and
4. Identify Master Plan and development regulation amendments that would be necessary for Independence Township to conform to the Highlands Preservation Area and to consider potential benefits to the Township through the possibility of Planning Area Conformance or a Highlands Center designation; and

**WHEREAS**, it is understood that submission of an Initial Assessment grant application and acceptance of an initial assessment grant by Independence Township from the Highlands Council in no way commits Independence Township to take any future action to conform to the Highlands Regional Master Plan, but the grant program does provide funding for the municipality to investigate the impacts of Plan Conformance and consider potential benefits that may be afforded to Independence Township through participation in the Highlands Regional Master Plan; .

**NOW, THEREFORE BE IT RESOLVED**, that the Township Committee of the Township of Independence, County of Warren, State of New Jersey hereby authorizes the submission of the aforementioned Highlands Initial Assessment Grant Application to the Highlands Council.

**RESOLUTION OF THE TOWNSHIP OF INDEPENDENCE AUTHORIZING DISCIPLINARY ACTION TO BE TAKEN AGAINST CHIEF AIELLO IN THE FORM OF A SIXTY (60) DAY SUSPENSION WITHOUT PAY AS A RESULT OF THE NOVEMBER 9, 2017 PURSUIT**

**WHEREAS**, New Jersey Attorney General’s Policy and Procedures (the “Attorney General Guidelines”) state that any complaint against a law enforcement executive must be referred to the County Prosecutor’s Office; and

**WHEREAS**, the Warren County Prosecutor’s Office has advised it is investigating certain actions involving the Chief of Police, Keith Aiello; and

**WHEREAS**, based on that investigation Chief Aiello has been placed on administrative leave with pay; and

**WHEREAS**, the Appointing Authority received notice that the Warren County Prosecutor’s Office has completed a separate investigation stemming from the Chief’s conduct on November 9, 2017; and

**WHEREAS**, that investigation sustained that Chief Aiello violated in significant and life-threatening ways the New Jersey Attorney General’s Police Vehicular Pursuit Policy and the Independence Police Department Rules Manual; and

**WHEREAS**, the Appointing Authority has made the decision to bring disciplinary action with regard to the findings made in connection with the Chief’s conduct on November 9, 2017; and

**WHEREAS**, Chief Aiello was given the opportunity to contest a potential immediate suspension without pay before the Mayor and Committee at a hearing on March 5, 2019; and

**WHEREAS**, The Committee has taken into account the findings of the Warren County Prosecutor’s Office as well as the comments presented on March 5, 2019, and has decided on the appropriate disciplinary action.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the Township of Independence, County of Warren, State of New Jersey, as follows:

- 1) Chief Aiello will remain on paid leave due to the ongoing investigation by the Warren County Prosecutor's Office. That status will remain until such time as there is a hearing on the charges relating to the November 9, 2017 incident wherein the Township will be seeking to impose a 60 day suspension without pay.
