## **Resolution 23-19**

## SAFE AND SECURE COMMUNITIES PROGRAM

A RESOLUTION APPROVING PARTICIPATION WITH THE STATE OF NEW JERSEY FEDERAL GRANT PROGRAM ADMINISTERED BY THE DEPARTMENT OF LAW AND PUBLIC SAFETY.

WHEREAS, the Township of Independence wished to apply for funding of approximately \$ 16,200.00 with a match of \$163,613.95 for an approximate project total cost of \$179,813.95 for a project under the State of New Jersey Safe and Secure Communities Grant Program, and

WHEREAS, the Independence Township Committee has reviewed the accompanying application and has approved said request, and

WHEREAS, the project is a joint effort between the Department of Law and Public Safety and the Township of Independence for the purpose described in the application;

THEREFORE, BE IT RESOLVED by the Independence Township Committee that

- 1. As a matter of public policy, the Township of Independence wished to participate to the fullest extent possible with the Department of Law and Public Safety and does accept grant number 23-2112 for the period 8.11.22 to 8.10.23

WHEREAS, N.J.S.A. 52:34-6.2(b)(3) authorizes local contracting units to utilize national cooperative contracts as a method of procurement and to enter into national cooperative pricing agreements for its administration; and

WHEREAS, Sourcewell Cooperative Purchasing Program, hereinafter referred to as the "Lead Agency" has offered voluntary participation in a cooperative pricing system known as Sourcewell; and

WHEREAS, The Township of Independence, on January 31, 2023 applied for and were awarded membership (No. 39120) as an End User in the Sourcewell Cooperative purchasing program for the contract term commencing on January 2, 2020 and ending on December 20, 2023; and

WHEREAS, The Township of Independence, on January 30, 2023, duly advertised their intent to make a contract award under the Lead Agency's Sourcewell programs request for proposals under Sealed Bid/Proposal No. 110719-CNH-1;

NOW, THEREFORE, BE IT RESOLVED as follows: This RESOLUTION shall be known and may be cited as the National Cooperative Purchasing Resolution of the Township of Independence. Pursuant to the provisions of N.J.S.A. 52:34-6.2(b)(3), the Township Administrator is hereby authorized to enter into a cooperative pricing agreement with the Lead Agency based on the proposals submitted under Sourcewell program Sealed Bid/Proposal No. 110719-CNH-1. The Lead Agency shall be responsible for complying with the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey. This Resolution shall take effect immediately upon passage.

## 2023-03 First Reading/Public Comment

AN ORDINANCE OF THE TOWNSHIP OF INDEPENDENCE, COUNTY OF WARREN AND STATE OF NEW JERSEY, TO BE INCLUDED AS CHAPTER 356, "TAXATION," OF THE TOWNSHIP CODE TO ESTABLISH ARTICLE I, "100% DISABLED VETERAN TAX REFUNDS"

WHEREAS, pursuant to N.J.S.A. 54: 4-3.30, the dwelling house and the lot or curtilage whereupon the same is erected, of any citizen and resident of this State, honorably discharged or released under honorable circumstances, from active service, in time of war, in any branch of the Armed Forces of the United States, who has been or shall be declared by the United States Veterans Administration or its successor to have a service -connected disability declared by the United States Veterans Administration or its successor to be a total or 100 percent permanent disability, and not so evaluated solely because of hospitalization or surgery and recuperation, sustained through enemy action, or accident, or resulting from disease contracted while in such active service, shall be exempt from taxation on proper claim made therefor; and

**WHEREAS**, pursuant to <u>N.J.S.A.</u> 54:4- 3.31, upon review and approval of the required documentation by the municipal tax assessor, the assessor shall allow said exemption from taxation for the tax year in which the claim was filed; and

**WHEREAS**, pursuant to <u>N.J.S.A.</u> 54:4- 3. 32, the governing body of each municipality, by appropriate resolution, may return all taxes collected on property from prior years which would have been exempt had proper claim been timely made in writing; and

**WHEREAS**, the statutory intent to grant discretion to the governing body of every municipality has been affirmed by court decisions that have held that a municipality has discretion to grant or deny a taxpayer a retroactive refund of property taxes that has been paid from the effective date of the disability as determined by the United States Department of Veterans Affairs as set forth in N.J.S.A. 54:4-3.32; and

**WHEREAS**, the Township Committee desires to establish a formal policy providing that a retroactive refund of property taxes as set forth in <u>N.J.S.A.</u> 54:4- 3.32 shall be limited to the current year of the submission of a proper claim to the tax assessor as required by <u>N.J.S.A.</u> 54:4-30.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Independence in the County of Warren and State of New Jersey as follows:

**SECTION 1.** Chapter 356 of the Code of the Township of Independence, entitled "Taxation," is hereby established as follows:

Article I 100% Disabled Veteran Tax Refunds.

356-1 Definitions

"Dwelling House" as used in this Article, shall mean any one-family building or structure or unit in a horizontal property regime or condominium or multiple-family building or structure on that portion occupied by the claimant as his legal residence including any outhouses or appurtenances used for the dwelling's fair enjoyment.

"Curtilage" as used in this Article, shall mean the enclosed space of ground and buildings immediately surrounding the dwelling house and enjoyed with it for its more convenient occupation. In no event shall the "curtilage" exceed the minimum lot size in the zone in which the dwelling house and associate property are located.

§ 356-2 Property Tax Refunds

Pursuant to <u>N.J.S.A.</u> 54:4-3.30, the dwelling house and curtilage whereupon the same is erected, of a 100% disabled veteran (as defined in <u>N.J.S.A.</u> 54:4-3.30) shall be exempt from taxation on proper claim made therefor. A refund of property taxes pursuant to <u>N.J.S.A.</u> 54:4-3.32 shall be granted provided that the applicant submits a complete application to the Tax Assessor as required by <u>N.J.S.A.</u> 54:4-3.30. A retroactive refund of property taxes as set forth in <u>N.J.S.A.</u> 54:4-3.32 shall be limited to the date of the submission of a proper claim to the Tax Assessor as required by <u>N.J.S.A.</u> 54:4-3.30.

**SECTION 2.** All Ordinances of the Township of Independence that are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

<u>SECTION 3.</u> If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 4.** This ordinance shall take effect immediately upon publication as required by law.

# RESOLUTION AUTHORIZING ADDITIONAL TAX REIMBURSEMENT AND SETTLEMENT

**WHEREAS**, pursuant to N.J.S.A. 54:4-3.30, "the dwelling house and the lot or curtilage whereon the same is erected" of a 100% disabled veteran shall be exempt from the payment of property taxes upon the filing of a proper application; and

**WHEREAS,** pursuant to N.J.S.A. 54:4-32, it is within the governing body's discretion to return all property taxes paid retroactive to the time of actual disability; and

**WHEREAS**, the owner of the property (the "Property Owner") designated as Block 13, Lot 60 on the Tax Maps of the Township of Independence (the "Property"), filed a Claim for Property Tax Exemption on Dwelling of Disabled Veteran or Serviceperson dated September 27, 2022;

WHEREAS, the Property Owner was determined to be 100% disabled by the United States Veterans Administration pursuant to a decision dated September 24, 2021; and

**WHEREAS**, pursuant to N.J.S.A. 54:4-3.32 and by way of Resolution #22-72, passed on December 13, 2022, the

Township Committee declared that the Property Owner was entitled to a tax refund for a portion of the Property for the prorated tax year 2022 commencing from the time of the filing of the Claim for Property Tax Exemption on Dwelling of Disabled Veteran or Serviceperson (i.e. September 27, 2022); and

**WHEREAS**, the Mayor and Committee have elected to exercise their discretion pursuant to N.J.S.A. 54:4-3.30 and 3.32 to exempt the entire Property from taxation and return all property taxes paid since the time of the Property Owner's actual disability (i.e. September 24, 2021); and

**WHEREAS**, in connection with the aforementioned determination, the Mayor and Committee are desirous to refund the property owner retroactively to the effective date of disability stated in the Veteran Administration letter for any taxes paid by the owner in excess of the refund amount previously authorized pursuant to Resolution #22-72; and

**WHEREAS**, these amounts include \$3,712.55 for the year 2021 and \$8,981.07 for the year 2022.

**WHEREAS**, said refund shall be issued within thirty (30) days of the signing of a Release Agreement between the parties.

**NOW, THEREFORE BE IT RESOLVED**, that the Mayor and Township Committee has elected to exercise their discretion pursuant to N.J.S.A. 54:4-3.30 to exempt the entirety of the Property designated as Block 13, Lot 60 on the Tax Maps of the Township of Independence from taxation.

**BE IT FURTHER RESOLVED,** that the Mayor and Township Committee has elected to exercise its discretion pursuant to N.J.S.A. 54:4-3.32 to return all property taxes paid since the time of the Property Owner's actual disability (i.e. September 24, 2021).

**BE IT FURTHER RESOLVED,** that the Chief Financial Officer be and hereby is authorized to issue a refund in the amount of Twelve Thousand, Six Hundred Ninety-Three Dollars and Sixty-Two Cents (\$12,693.62) which represents full reimbursement for the payment of property taxes for the entirety of the aforementioned property beginning September 24, 2021, based on the Claim for Property Tax Exemption on Dwelling of Disabled Veteran or Serviceperson as indicated below:
